Ms. Phyllis Sharbo, Assessor, reviewed this matter and stated that everything was in order and she also stated the conditions for approval.

MOTION by BUCCI seconded by GOODHUE to approve the Land Division/Combination for Lot Numbers 7, 8, 9 and 10 of the Pine Valley Subdivision, being Permanent Parcels 08-04-112-012, 08-04-112-011, 08-04-112-010 and 08-04-112-009 as conditioned by the Township Assessor.

8. Award of Bid for Sale of Huntcliff Village. (Tabled from August 11, 2010)

MOTION by BUCCI seconded by KOEHS to set the minimum bid price for the Condominium Unit at Huntcliff Village at sixty five thousand dollars (\$65,000.00) and that the property be cleaned up and all Condominium Association fees accrued since the Township took ownership be paid and the current taxes be paid as well.

9. Request to Approve the Veterans Memorial Agreement; Macomb Township Community Foundation.

Clerk KOEHS reviewed this matter and stated that the agreement was now ready for consideration. He further stated his recommendation for approval.

MOTION by KOEHS seconded by KRZEMINSKI to approve the Veterans Memorial Agreement between the Township of Macomb and the Macomb Township Community Foundation and authorize the Supervisor to sign it.

10. Request to Award Custodial Services Bid; Parks and Recreation Center.

Mr. Lawrence Dloski, Township Attorney, reviewed this matter and stated that in his professional opinion the township was precluded from awarding the bid for this service to Kristel Cleaning because the bid they submitted did not comply with the requirements for bidding.

MOTION by BUCCI seconded by KOEHS to award the bid for Custodial Services for the Parks and Recreation Center to ABM in the amount of three thousand two hundred twelve dollars (\$3,212.00) per month for a period of three (3) years.

12. Request to Adopt a Resolution in Support of Domestic Violence Awareness Month.

Clerk KOEHS reviewed this matter and stated the EMILY Fund, a non-profit organization advocating for victims of domestic violence, has requested that the Board consider the adoption of a proclamation to recognize October as 'Domestic Violence Awareness Month'.

MOTION by KOEHS seconded by KRZEMINSKI to adopt the following proclamation:

PROCLAMATION OF THE BOARD OF TRUSTEES

At a regularly scheduled meeting of the Macomb Township Board of Trustees called to order by Supervisor GRABOW at 7:00 p.m. on Wednesday, September 8, 2010, the following proclamation was offered by Clerk KOEHS and supported by Trustee KRZEMINSKI:

WHEREAS, domestic violence is a serious crime that affects people of all ages, races, gender and income levels; and

WHEREAS; domestic violence is widespread and affects over four million Americans each year; and

WHEREAS; one in three Americans have witnessed an incident of domestic violence; and

WHEREAS; children that grow up in violent homes are believed to be abused and neglected at a higher rate than the national average; and

WHEREAS; domestic violence costs the nation billions of dollars annually in medical expenses, police and court costs, shelters, foster care, sick leave, absenteeism and non-productivity; and

WHEREAS; only a coordinated community effort will put a stop to this heinous crime; and

WHEREAS; Domestic Violence Awareness Month provides an excellent opportunity for citizens to learn more about preventing domestic violence and to show support for the numerous organizations and individuals who provide critical advocacy, services and assistance to the victims;

NOW THEREFORE, the Macomb Township Board of Trustees does hereby proclaim the month of October as DOMESTIC VIOLENCE AWARENESS MONTH and urge all of our citizens to work together to eliminate domestic violence from our community.

- b. Supervisor GRABOW informed the Board that the Macomb County Sheriff Department and Target Stores have contributed a five hundred dollar (\$500.00) grant to offset the cost of buying equipment for the School Crossing Guards.
- c. Supervisor GRABOW asked the Board for permission to institute the creation of a Team Leader position for the School Crossing Guards. This position would oversee the attendance records for the various school assignments. They would be compensated at the rate of ten dollars (\$10.00) per week in addition to their regular pay.

MOTION by KOEHS seconded by DUNN to approve the request to institute the Team Leader position for the School Crossing Guards and to compensate them with an additional ten dollars (\$10.00) per week.

MOTION by KRZEMINSKI seconded by BUCCI to approve the request for any Board member to attend the October 6, 2010 MTA training session at a cost of eighty nine dollars (\$89.00) per attendee.
